

Equity Indicator 7

Indicator: Workforce Conditions, Preparation, and Development

Definition: Working conditions such as breaks, paid planning time, and adult-child ratios are currently being addressed for subsidized programs through the Rate and Quality Reform work advancing a single-rate structure. When defining quality, consider these working conditions for fee-based and non-subsidized programs as well subsidized programs. When defining requirements for higher education and professional learning, consider access for all, especially members of the workforce from marginalized and underserved communities.

High-level Overview of Other State Efforts

- Some programs are offering teachers both individual and collaborative paid planning time.
- Some states are establishing a benefits package for staff that includes at least four of the following: paid leave for professional development, paid planning time, vacation, sick time, retirement, or health insurance.
- Some States are introducing a salary schedule and merit bonus systems that reward educational training (i.e., degrees, certificates, etc.) in early childhood.
- Some states are implementing intentional follow-up (i.e., coaching) to support the application of content learned during Professional Development.
- Some programs are developing program-wide and individualized professional development plans that align with the specific needs of program.

High-level Overview of Some Other State Efforts

Communication is tailored across different groups (families, program types, public, etc.)

- Some states are providing one-pagers in multiple languages, featuring frequently asked questions and engagement opportunities for families and programs.
- Some states are sharing information with early learning communities through local advertising channels (i.e., radio, parent periodicals, newspapers, etc.).
- Some states are engaging in public awareness campaigns to promote transparency (i.e., social media, videos, badges, etc.).

High-level Overview of Some Other State Efforts

- Some states are collaborating with their early learning coalitions to keep provider profiles updated with information on quality and program highlights (i.e., hours of operation, types of curricula used, etc.).
- Some states are leveraging their Child Care Resource & Referrals networks to engage and increase the supply of high-quality care in targeted communities.
- Some states are engaging in revision processes following the Plan Do Study Act cycle approach, allowing them to pilot components of QRIS and make adjustments to better understand how the components best fit together.
