- <u>Advisory for Peer Support Services in Crisis Care</u> (PDF) This June 2022 advisory from the Substance Abuse and Mental Health Services Administration (SAMHSA) discusses the role of peer support workers and models of peer support services that are available to assist individuals who are experiencing a crisis. Peer support services are a vital component of crisis care.
- Defining "Peer Support": Implications for Policy, Practice, and Research (PDF) – This 2018 scholarly article by Darby Penny, MLS, Advocates for Human Potential, Inc., addresses the substantial issues involved in defining peer support, offers a brief consideration of the history of two types of peer support, examines recent review articles on peer support in mental health, and discusses policy and practice implications.

- Kaiser Family Foundation (KFF) table on <u>Medicaid Behavioral Health</u> <u>Services: Peer Support Services</u> lists services covered, whether copayments are required, and service limits in each state.

- National Academy for State Health Policy (NASHP) August 30, 2022 blog post and chart: States' Use of Peers in the Mental Health Crisis Continuum highlights the policy components of four states' approaches to including peers in providing services across the crisis continuum (New Mexico, Minnesota, Michigan, and Virginia).

On this Apple podcast Episode 91, Nze shares their mental health journey and how they are working with the same Warmline they called while in crisis. They talk about their experiences with peer respites, not using anything carceral in the program and dealing with crisis through a lens of grief.
