

Culminating Three Years of Stakeholder Engagement



- CA2030 Steering Committee met 10 times (C4A, CCOA, CSAC, CWDA, CFILC)
- 80 stakeholder interviews
- In person/virtual interviews with all 33 AAAs
- First statewide survey of 17,700 older Californians
- Four public webinars with 736 participants
- Public legislative process to enact SB 1249 (Roth)
- Half-day workshop with CDA and C4A membership
- Nine webinars for AAAs-only
- Four surveys of all 33 AAAs



Recommendations



- 1. Adopt consistent data reporting standards and timelines for existing statewide programs** – Congregate and Home-Delivered Meals, Caregiver Supports, and Information & Assistance with a public facing data dashboard.
- 2. Update Intrastate Funding Formula (IFF)** – for first time since 1995 to account equally for age, disability, income, geographic isolation, and equity.
- 3. Designations/De-Designations** – Establish a transparent process that allows for public and community input to comply with federal final rule regarding "right of first refusal" for local government jurisdictions.





Medi-Cal HCBS Managed Care Integration Planning

October Update

Goals for Integrating HCBS Programs into Medi-Cal Managed Care Plans (MCPs)

- » Strengthen California's success in rebalancing its long-term services and supports (LTSS) system toward HCBS by giving MCPs the ability and incentive to offer members home and community-based alternatives to institutional long-term care
- » Integrate and coordinate members' LTSS with health care services covered by MCPs
- » Place accountability with one entity (the MCP) for LTSS member outcomes (access, quality, costs)
- » Create greater financial predictability of Medi-Cal HCBS costs by including them in managed care capitation rates

Medi-Cal HCBS Program Integration into Managed Care: Current Plans

- » DHCS is developing a multi-year roadmap outlining specific steps to integrate four HCBS programs into managed care integration **no sooner than** January 1, 2028
 - Multipurpose Senior Services Program (MSSP)
 - Home and Community Based Alternatives (HCBA)
 - Assisted Living Waiver (ALW)
 - Medi-Cal Waiver Program (MCWP)

Medi-Cal HCBS Program Integration into Managed Care: Current Plans (cont.)

- » HCBS programs not currently planned for managed care integration, but will require coordination with managed care:
 - In-Home Supportive Services (IHSS)
 - California Community Transitions (CCT)
 - Programs for individuals with developmental disabilities, including the HCBS-DD waiver and the Self-Determination Program

Approach to Designing HCBS Integration

- » Strategy Committee made up of representatives from across DHCS, CDA, and CDPH launched in Fall 2024 that meets regularly on program design and implementation
- » DHCS launched the HCBS Integration Workgroup in April 2025, including 23 representatives from the following groups:
 - Managed care plans and their associations
 - HCBS case management entities
 - HCBS providers and their associations
 - Medi-Cal members receiving HCBS and their caregivers
 - Policy experts and consumer advocacy organizations
- » DHCS also provides regular updates on HCBS managed care integration during established meetings with managed care plans, providers, members, and advocates

HCBS Integration Planning: Key Milestones



Strategy Committee meets weekly; DHCS provides monthly updates in Public Forums

Key Decision: Maintain or Blend HCBS Waiver Programs Selected for Managed Care Integration?

The state could take two approaches to transition HCBS programs to managed care:

Option 1

"Lift and shift" approach

- Amend the four existing HCBS waivers to require individuals in the HCBS programs to receive services through managed care plans under the state's existing 1915(b) managed care waiver.

Option 2

"De novo" waivers

- Consolidate the current waivers into new 1915(c) waivers, with some combination of the existing services available under the current waivers.
- Considering two waivers to target different populations: children and adults.
- DHCS, CDA, and CDPH could choose for the waiver to share some/many of the characteristics of the existing waivers, as appropriate.
- New 1915(c) waivers would be designed to operate concurrently with existing 1915(b) managed care waiver.

Preferred approach

HCBS Integration Planning Updates

- » DHCS is considering two approaches to integration:
 - Maintain the four existing HCBS waivers
 - Consolidate the four existing HCBS waivers into two "de novo" 1915(c) waivers, for youth and adults
- » To determine which approach to use, DHCS has been working with key partners and the Workgroup to:
 - Develop an initial design for the de novo waivers
 - Develop assumptions about waiver services, providers, and populations
- » Results of financial analysis will help DHCS evaluate two approaches and refine waiver design

HCBS Integration Planning Updates (cont.)

- » DHCS plans to use Section 1915(c) HCBS waiver authority concurrent with the state's existing 1915(b) managed care authority to integrate HCBS
 - Other authorities were considered but determined not to be feasible in the current budget environment
- » DHCS will implement Enhanced Continuity of Care (CoC) requirements for current waiver enrollees to maintain their current waiver services during the transition period to managed care
 - Requiring MCPs to contact non-contracted providers prior to the transition to achieve a timebound CoC agreement (Enhanced CoC for providers)
 - Requiring MCPs to automatically continue authorized services (Enhanced CoC for services) for a set period of time (for example, 12 months)

Discussion Topics from Recent HCBS Integration Planning Workgroup Meetings

- » The Workgroup has convened for eight sessions from Apr–Aug 2025
- » The Workgroup has discussed the following topics to date:
 - Federal authorities for implementation
 - Maintaining or blending current waivers
 - Considerations for statewide integration
 - Populations that would be served by the de novo waivers
 - Member supports to ensure continuity of care
 - Service packages and service definitions for the de novo waivers
 - Anticipated changes in service use and provider availability under the de novo waivers

Discussion Topics from Recent HCBS Integration Planning Workgroup Meetings (cont.)

- » Workgroup meeting materials and updates will be shared on DHCS's new [HCBS Integration webpage](#)

Key Takeaways from Recent HCBS Integration Planning Workgroup Meetings

- » Workgroup members emphasized that HCBS integration should prioritize:
 - Expanding availability of waiver services statewide
 - Increasing waiver slots to expand access
 - Reducing system complexity, including eligibility and enrollment processes
 - Balancing standardization with specialized needs of specific populations

Key Takeaways from Recent HCBS Integration Planning Workgroup Meetings (cont.)

- » Workgroup members raised considerations for integration planning:
 - Importance of managed care plans partnering with community-based providers with local knowledge and relationships
 - Ensuring appropriate oversight of managed care plans and assessing system readiness for the transition
 - Setting timelines that enable relationship building, contracting, and data sharing between providers and managed care plans

Discussion Topics for Future HCBS Integration Planning Workgroup Meetings

» In upcoming meetings, DHCS anticipates that the Workgroup will discuss the following topics:*

- Data systems and data sharing
- Enrollment caps and waitlist policies
- Provider enrollment and supports
- Payment models to incentivize quality care
- Managed care plan quality and oversight
- HCBS network adequacy standards
- Case management roles and responsibilities
- Assessing overall system readiness for integration

*These topics are informed by Workgroup feedback and subject to change based on stakeholder and DHCS leadership priorities.

Next Steps

- » The HCBS Integration Planning Workgroup will reconvene in October 2025 and continue meeting monthly
- » DHCS anticipates the results of the financial analysis in late Fall 2025
- » DHCS is determining how to structure roles, responsibilities, and oversight mechanisms for different entities under managed care
 - Learning from experiences of other states that deliver HCBS in managed care

State Transit Transformation Task Force - Accessibility

- State Transit Transformation Task Force was created by the 2023 budget providing funding for public transportation (SB125)
- Task force to make recommendations to the Legislature and Administration to fund and improve transit, due in October 2025
- Members from business, labor, academics, advocacy groups, agencies
- Initially unclear if it would cover accessible transportation
- Thanks to vocal support and advocacy there are good recommendations! Laurel Paget-Seekins of Public Advocates on Task Force, David Azevedo of AARP on Technical Advisory Committee, many community member comments

Funding - Overall

Recommendations:

- 2023 Wicks accessible transportation bill stalled because cost was unknown
- SB 1121: State and local transportation system needs assessment
- SB 125: Transit Transformation Taskforce (TTTF)

Funding - Specific

Recommendations:

- Medical transportation: Cost sharing agreements
- Local/regional priorities: Greater flexibility to determine priorities for Federal Section 5310 funds
- TNC Access for All
- Free and discounted trips

Coordination

Recommendations:

- Coordination
 - Link, expand, and unified services
 - 'One-seat ride' services
 - Health care, social service, and transit provider strategic planning
- Tools and Systems
 - Paratransit eligibility model language and guidelines
 - ADA accessible statewide eligibility verification
 - Booking software
 - Trip planning data and tools
 - Technical assistance to operators for eligibility verification

- ADA Transition Plans
- Inventory of transit stop accessibility
- Standards for Accessible Wayfinding
