At the core of her leadership is a clear belief: that early education lays the foundation for lifelong success, and that every child deserves the opportunity to begin their educational journey in a supportive, high-quality environment.

**Gabriela Orozco Gonzalez**, of Los Angeles County, is a member of the California State Board of Education and a second-grade teacher in the Montebello Unified School District, where she has served students and families for over 25 years. She has taught across grade levels and is committed to advancing equitable, student-centered instructional practices that support access, engagement, and strong academic foundations for all learners. Gonzalez has contributed to statewide assessment efforts as a performance task writer and item reviewer for the Smarter Balanced Assessment Consortium, with a focus on accessibility and bias reduction. She is the co-founder and chair of the Heising-Simons Foundation, which she established with her husband, Mark Heising, in 2007. The foundation is dedicated to advancing sustainable solutions in climate and clean energy, enabling groundbreaking scientific research, enhancing early childhood education and care, and supporting human rights in the United States.

Throughout her career, Simons has championed efforts to create a more just and equitable society. Her professional journey spans philanthropy, nonprofit leadership,

and education, with a focus on supporting young learners and improving outcomes for vulnerable children. Before establishing the foundation, Simons began her career as an educator, teaching in Spanish-bilingual and English as a Second Language (ESL) classrooms in under-resourced schools. She later founded Stretch to Kindergarten, an innovative early childhood program designed to support young learners during the critical transition into formal schooling.

Simons is a board member of Math for America, which supports excellence in STEM teaching, and the Learning Policy Institute, which conducts and communicates research to improve education policy and practice. She is also deeply involved in organizations dedicated to criminal justice reform, including The Marshall Project, One for Justice, and Smart Justice California.

Simons earned her bachelor's degree in journalism from the University of California, Berkeley, and her master's degree in education from Stanford University.

**Dr. Matilda Soria**, of Fresno, is the Executive Director of the Child and Family Success Division at the Office of the Fresno County Superintendent of Schools (FCSS). In this capacity, she oversees the Early Care and Education, Health Services, Cradle to Career, and Foster and Homeless Youth Education Services Departments. She also supports government relations efforts, advancing policies that improve outcomes for children and families across the region and state. With more than 20 years of experience in educational leadership, systems development, and cross-sector collaboration, Dr. Soria has led initiatives that strengthen early learning, family and community engagement, and workforce development. She has been with FCSS since 2015, serving in roles including Senior Director and Program Coordinator for Early Care and Education. Prior to her work at the county office, Dr. Soria spent over a decade at Reading and Beyond, where she held leadership roles including Research and Development Director and Director of the Parent Information and Resource Center. She also served as an Adjunct Professor at California State University, Fresno. A proud product of Fresno County's public schools, Dr. Soria remains deeply committed to the community she serves. She currently serves on the boards of Fresno Metro Ministries (a community-based organization focused on advancing health, environmental quality, economic development, and resilience in the San Joaquin Valley) and Storyland (a beloved literacy-themed park in Fresno). Dr. Soria earned her Doctor of Education in Educational Leadership and her Bachelor of Arts in Psychology from California State University, Fresno, and her Master of Education in Human Development and Psychology from Harvard University.

She began her career as a substitute in a family child care home, then worked for her local Resource and Referral agency, before becoming a licensed family child care provider. She has mentored emerging professionals at both UC Davis' and Cal Poly Humboldt's lab schools, founded and directed a non-profit community-based child care center, taught at both the community college and state university levels for more than two decades, and served as a consultant on quality improvement in K-12 schools.
