Layla Anderson, *Self Advocate*

Tony Anderson, *Association of Regional Center Agencies*

Tony Anderson entered the field of developmental services in 1987 and began his career as a direct support professional in homes, day programs, and schools. He has served as a social worker and later became the Executive Director of a community non-profit that served over 120 people with developmental disabilities. He worked in the leadership for the Napa County Department of Health and Human Services and was appointed Deputy Director by Governor Gray Davis, responsible for Policy, Planning, and Governmental Relations at the State Council on Developmental Disabilities. He joined The Arc California in 2003 and served as Executive Director and principal lobbyist for the association. In this capacity, he served on numerous state and national boards and commissions and was the national President for the executive directors of the association. In 2017 he became the Executive Director of Valley Mountain Regional Center serving 20,000 people with developmental disabilities and their families in Amador, Calaveras, San Joaquin, Stanislaus, and Tuolumne Counties. Today Mr. Anderson is the Associate Director and lobbyist for the California regional centers (ARCA) responsible for organizational leadership and strategic partnerships, community engagement in policymaking, and policy advocacy. After retiring from the Capitol staff, he served as Public Policy Director of The Arc & United Cerebral Palsy California Collaboration, retiring from that position to his current volunteer role. He developed, drafted and successfully lobbied major legislation such as the Senior and Disability Justice Act and much of California's hate crime law, including extensive sections on anti-disability hate crimes. He has served as a subject-matter expert assisting the Commission on Peace Officer Standards and Training with many police training projects on elder and disability abuse, hate crimes, and related crimes. He has taught California District Attorneys Association and U.S. Internal Revenue Service classes for prosecutors and IRS agents. He earned an MA in government from California State University, Sacramento, where he also taught California state and local government, and a BA in political science from San Francisco State University. He has life-long attention deficit disorder.

Aneliza Del Pinal, *California Association of Area Agencies on Aging (C4A)*

Aneliza is Chief Executive Officer of Sourcewise, the Area Agency on Aging (AAA) covering Santa Clara County. In this capacity, she directs the JD Concentration in Health Law & Policy, co-directs the Master of Science in Health Policy & Law Degree (HPL) and serves as the Policy Director of the Medical-Legal Partnership for Seniors clinic.

Professor Hooper has dedicated her career to developing innovative medical-legal collaborations that can advance equity in health care. She has a special interest in complex care, and in particular the role of law and lawyers in improving systems of care for underserved older individuals with complex medical and social needs.

Her work encompasses clinical interventions such as the Medical-Legal Partnership for Seniors Clinic, research collaborations such as the Care Ecosystem trial, and educational initiatives for providers and the public such as the Statewide Medical-Legal Learning Collaborative of the Dementia Care Aware Initiative, Optimizing Aging Collaborative and PREPARE. CDAAs Elder Abuse Committee. Scott also was instrumental in 2021 in creating the first of its kind San Diego FBI Elder Justice Task Force in collaboration with the FBI, APS, US Dept. of Justice, and San Diego local law enforcement to combat, investigate, and prosecute Elder Abuse Scams.
