



Developing Our Recommendations



- Discuss "big" ideas: Talk about ideas for recommendations
- 2. Draft recommendations: Co-Chairs and staff will use the "big ideas" to develop draft recommendations
- 3. Review with Workgroup: Members discuss and revise draft recommendations
- 4. Review with Master Plan Committee: Recommendations presented to the Master Plan Committee for feedback and approval





Priority #1: Make it easier for people to get the health and human services they need, when they need them. These services are called generic services. We will do this by:

- Helping people learn about the services available
- Using new ideas and technology to make things easier
- Giving people support to help them get the services they need

Workgroup 2 Priorities



• **Priority #2**: Make life transitions easier, better, and on time. Life transitions are moving to school services from early start. They also include leaving high school and getting older.

• **Priority #3**: Help individuals and their families use community resources. These will help meet their basic needs. These will help support them being part of their community.

Think About the Equity Tool: Our Goal



 Universal Goal Setting → Our Priority #1tells us where we want to be

Priority #1: Make it easier for people to get the health and services they need, when they need them. These services are called generic services.

Next Steps:

- 2. Problem Statement → Where are we now? Are there groups left behind?
- 3. Causes of Problem → What are the reasons people can't get generic services? Why are we here?
- 4. Information → What data or information will help answer these questions?

Use the Equity Tool to Develop our Problem Statement



Priority #1 Our goal: Make it easier for people to get the health and human services they need, when they need them. These services are called generic services.

Let's discuss:

- 1. Problem Statement -> Where are we now? Who is left behind?
- 2. Causes of Problem → Why are we here?
- 3. Information → What data or information will help answer these questions?



Workgroup 2 members and public comments gave us good ideas about how to make it easier to get generic services.

We are going to talk about 5 "big" ideas. And ask for other "big" ideas. For each big idea think about:

- What needs to be part of the "big" idea to make it work?
- Are there tools that need to be developed?
- Is there information we need to make our "big idea" great?
- Are there questions or concerns about this "big" idea?





Big Idea #1: Create plain language information, about generic services. This includes how to access these services.

- What needs to be part of information about generic services?
- Are there tools or formats that need to be developed?
- Is there information we need to make this information great and usable by lots of people?
- Are there questions or concerns about this idea?





Big Idea #2: Screening tools to refer people to the right generic services

- What needs to be part of a screening tool?
- Are there ways or formats that would make the screening tool work best?
- Is there information we need to make the screening tool great and useable by a lot of people?
- Are there questions or concerns about this idea?





Big Idea #3: Common application for generic services

- What needs to be part of a common application?
- Are there ways to design a common application that would make it work best?
- Is there information we need to make the common application tool great and useable by a lot of departments?
- Are there questions or concerns about this idea?





Big Idea # 4 Help to get generic services. These are called navigation supports. They can include peer support services.

- What needs to be part of a navigation supports?
- Are there best practices that make navigation supports help more people?
- Is there information we need about navigation supports to make sure they help lots of people?
- Are there questions or concerns about this idea?



Big Idea # 5: Test or pilot ways for regional centers to provide services and bill the responsible generic agency. For example, speech or behavior therapy services that a managed care provider should provide but is not available.

- What needs to be part of a pilot program where regional centers pay for services and bill a generic services agency?
- Are there ways to design the pilot that would make it work best?
- Is there information we need about this pilot?
- Are there questions or concerns about this idea?
