Summary of California AB 2832 -Whole Child Community **Equity Bill** (Slide 1 of 3)

# CA Department of Social Services (CDSS) in collaboration with the CA Department of Education (CDE):

Convene a public workgroup to provide recommendations to support the development of:

- A Whole Child Community Equity Framework
  - To serve as the guiding foundation for the creating of a Whole Child Community Equity Tool
- A Whole Child Community Equity Tool

 To inform early childhood investments and whole child resources to address racial and economic inequities for California's youngest children.

Summary of **California AB** 2832 -Whole Child Community **Equity Bill** (Slide 2 of 3)

#### Whole Child Community Equity Framework

- The Framework will outline categories essential to supporting children through a whole child approach.
- Categories can include access to child care, health and mental health services, education, supports to address childhood adversity and community safety, economic well-being, and built environments.
- Additional categories discussed: maternal child health & environmental conditions



Summary of **California AB** 2832 -Whole Child Community **Equity Bill** (Slide 3 of 3)

#### Whole Child Community Equity Tool

- Will help the state to identify the conditions within communities that impact children's growth and development.
- Will provide the data that enables leaders to make informed decisions to target resources and policies where they would have the greatest impact.

 CDSS and CDE are required to form a workgroup of stakeholders to inform the development of the Whole Child Community Equity Framework and Tool

#### Workgroup composition

- Child care providers
- Early childhood advocacy groups
- Early childhood research groups
- Education
- Family service and advocacy groups
- ECE workforce organizations
- Parents and family members from historically underserved communities

#### Whole Child Workgroup: Roles & Responsibilities

The workgroup is tasked with providing recommendations to the CDSS on:

- Development of a Framework that outlines categories that are essential to supporting the needs of children ages birth through age 13.
- Development of the Equity Tool, including identifying a set of common indicators aligned with the Framework's categories to assess community needs, prioritize high-need areas, and monitor progress toward reducing economic and racial disparities.



# Whole Child Workgroup: Roles & Responsibilities

The workgroup is tasked with providing recommendations to the CDSS on:

- ✓ Potential uses of the Equity Tool to inform early childhood investments and whole child resources.
- ✓ Final development of the Framework, Equity Tool and recommended uses of the Tool before they are presented to the Legislature.



#### Whole Child Workgroup: Work to Date

- Defining "Whole Child" and "Equity
- Exploring existing indicator sets and indices
- Exploring indicator categories for the Framework and Tool
- Exploring state administrative data available to populate the Tool
