Review of Agenda and Session Objectives

Rob Muschler, Senior Consultant, Health Management Associates, began the workgroup meeting by explaining Zoom functionality, overviewing the Workgroup 6 Meeting 2 agenda, and introducing the co-chairs and member list. He then provided an overview of how to submit public comments and the meeting code of conduct.

Rob then provided a description of the AB988 project structure and desired outcomes, as well as the Workgroup's areas of focus. He also briefly reviewed input from the December Policy Advisory Group meeting and from other workgroups that were relevant to funding and sustainability.

Surcharge and Fund Condition Statement – CalOES Presentation

Budge Currier, Assistant Director of Public Safety Communications, CalOES presented an overview of the 988 Surcharge and Fund Condition Statement and allowed time for Q&A.

Discussion included questions about whether CalOES and DHCS will coordinate on data collection from Centers; whether there is a process for mobile crisis providers to seek surcharge funding (Budge indicated that they know this is an area that needs to be explored further); how CalOES will ensure that centers aren't using 988 dollars to support other business lines (Budge indicated that Centers will submit their budgets); how CalOES makes funding determinations and whether they're considering the ICMI model and the long duration of texts/chats (Budge indicated they will meet with Centers shortly to discuss further); whether funds can be used for supervisorial staff (Budge indicated they could); and whether CalOES would share what it learns about Call Center costs (Budge indicated that they would share information if Call Centers gave permission). A representative from CBHDA also made the case that mobile service providers/Counties should be eligible to receive surcharge dollars to cover uncompensated services (e.g. services to uninsured and commercially insured individuals).

Discussion of Fund Utilization and Criteria

Rob Muschler then led the group in reviewing the feedback collected during Meeting 1 and asked for any revisions, edits, or additions.

Discussion I focused on previous input provided in response to the following question: Based on the parameters outlined in the legislation and applicable codes, how could funds be best utilized to ensure an effective, equitable, and accessible crisis response system?

Discussion focused on how surcharge funds could be used to support the crisis response system. Participants discussed paying for 988 center supervisory staff and overhead; costs associated with data collection; uncompensated mobile crisis services; material supports for mobile crisis service recipients (e.g., clothing, shoes, water, etc.), short-term capacity building for centers; and supports for call takers. Participants also noted that it is important to ensure that commercial insurers are paying their "fair share" so that the surcharge isn't subsidizing costs that they should be covering.

Discussion 2 focused on previous input provided in response to the following question: What criteria should be considered in order to receive 988 surcharge dollars? Discussion focused on criteria for receiving funds. Participants had limited comments and/or additions but noted the need for quality assurance and the reporting of outcomes that align with the discussions being had in Workgroup 5, Data and Metrics.

Lastly, HMA provided a brief overview of the agenda for Meeting 3, which will focus on commercial insurance coverage.

Public Comment Period

Rob Muschler shared instructions for how to make public comment and said that comments can also be submitted at any time via email at AB988Info@chhs.ca.gov. There were no public comments.

Meeting Wrap-Up and Next Steps

Rob Muschler mentioned that the next workgroup meeting will be held on August 27th, following the next Policy Advisory Group meeting in August.
