# Gay Youths More Likely to Report Trouble in Foster Care, Study Finds

Gay foster youths are twice as likely to report being treated poorly by the foster care system than their straight counterparts, according to a new study of Los Angeles County's foster care system. A 10-month investigation found that nearly 1 out of every 4 adolescents in California's foster care system is receiving these drugs — 3 times the rate for all adolescents nationwide. # Number of Non-Minor Dependents Continues to Grow, Reaching 7,670 Youth

John Burton Foundation Updates - July, 22, 2014

The Child Welfare Indicators Project at UC Berkeley has released the latest data on children and youth in California's foster care and juvenile probation systems. According to the data, available through April 1, 2014, the number of non-minor dependents in California continues to rise, reaching a total of 7,670 on April 1, 2015. Of this total, 18 percent are from the juvenile probation system and the remaining 82 percent are from the child welfare system. As the total number of NMDs has increased, the number of 20 years-olds has experienced the highest level of growth, up from 274 NMDs on April 1, 2013 to 1,595 NMDs on April 1, 2014. This large cohort of 20 year-olds will be reaching age 21 in 2015, three years after extended foster care went into effect on January 1, 2012. http://johnburtonfoundation.org/images/Website/April 1 2014 Data on from the.pdf

# **Child Maltreatment May Actually Be Declining**

Psychology Today – David Rettew, M.D. - August 11, 2014 (Journal)

To the surprise of many, the rate of victimization significantly dropped from 2003 to 2011 for slightly over half of the variables studied, including rates of bullying, assault victimization, sexual victimization, as well as youth perpetrating acts of violence and property crime against others. The overall rate of child maltreatment during this period dropped by 26 percent. Declines were also observed for the period between 2008 and 2011, although not as dramatically. For no variables did the rate significantly increase.
