- Daniel: Would like Berkeley to host a webinar with individuals who submitted comments/questions. Then present in December.
- Question: Were models in other states, or jurisdictions, looked at when creating this?
 - Actually on the cutting edge of other states. Recommendations: Look at Illinois policy perspective on data sharing, NY, San Diego opt in/out policy.

Presentation: Barry L. Zimmerman, Director Ventura County Human Services Agency Ventura County Foster Health Link

- Provides access to medical records to caregivers 24/7 on desktop/mobile only surrounding their own child.
 - Can include school records (grades, etc.) in future phases.
 - Social workers also have access. Change of social workers will be updated itself.
 - Ability to print immunization history (i.e. for schools). Currently, can't print anything else-- didn't see the need.
 - No teenagers at this time, because can only have information until age 12, due to reproduction. Future phases will look how to segregate it out.
- If history notes mental depression, can connect to resources.
 - Where is this information coming from?: Network of Care; Trilogy. Have a subscription program with them, their responsibility to update links.
- Questions/Clarifications:
 - Foster care parent can't input in site?: Currently no third-party access. Can't judge if caregiver is legitimate in input.
 - Can it all be consolidated in one views?: Yes, would just take more time/money.
 - How long to build?: 6.7 yrs ago in concept. Less than 6 months to develop.
 - O Do you keep a databook for variables you can access? Yes, IT folks maintain.
 - O Usage?: Slow uptake, seasonal use (beg. of school year). Translates to Spanish, except medical terms. No charges on a use basis, acts as patient portal.
 - o Training process: Social workers, support staff, eligibility staff, etc.
 - O Ventura has 99% insurance provided by same company, how replicable is it?: For ease: 1 company is easy. But still is replicable in other counties.
 - What considerations for aggregate, management?: No haven't looked at that. For analytics would need to access and manipulate data.

Foster Youth Participation in the CalFresh Program A

- ABAWD: No data to identify this subpopulation. How many youth? 150 to 200k adults a month. Lots of in and outs in the 3 month program.
- 97% exact match for these 20k individuals, to link data.
- Household issue: Rules around purchase and preparing together. If not purchasing and preparing together, than can be a household of 1 even when living with large # of people. It is a self-certification.
- Many eligible people, however many undocumented. Methodology where we can take out undocumented population.
- Next steps: What can we do? Many don't have documentation, etc.
 - Need to figure out outreach, county/department responsibilities.
 - National Youth in Transition Database. Anthony: Just a portion of youth.
 Database only represents 50% of youth. Might be better ways in addition to that.
 - Laurie: Cal Youth in the Loop: "nothing for us without us." Welcome to look at survey for foster youth online.
