- National/State/Local Project Updates—brief summaries and updates on progress of national, state and local initiatives
 - o The Children's Partnership: http://www.childrenspartnership.org
 - Ventura County: big event to launch Foster Health Link (linking Electronic Health Records to Child Welfare records) on Tuesday with a presentation to the Board of Supervisors
 - Pilot in Sacramento County to use Health Shack (which provides transitional age current/former foster youth access to their health records) to assess and implement AB12
 - Working with CDSS to gather advocate input on the CWS/CMS redesign; there will be a report on this input from a diverse range of stakeholders/advocates will come out at the end of June
 - Full strategic plan for PHR (Personal Health Records) system for children and youth in foster care is complete. There will be a shorter version available on the website
 - Article in Politico on parents' resistance to data mining, particularly with respect to educational data, is a reminder that we need to be thinking about how we frame data sharing/data linkage

 - Larry Bolton: conversations with county councils, AOC (Administrative Office of the Courts, and CDSS are happening to revalidate data exchange agreements and submit them to OSI (Office of Systems Integration)
 - Stewards of Change recently convened workgroups on data sharing/integration
 results/recommendations of these efforts will be disseminated soon
 - L.A. Data 2.0 conference is happening today focusing on open data for addressing/improving health – proceedings will be posted
 - CDPH (California Department of Public Health) has launched an open data website focusing on building health community through data sharing
 - New federal performance measures (Child and Family Service Reviews 3) were released on the federal register for public comment. 30 day period has passed and it is expected the final rule should be coming out fairly soon (since there was a tight timeline for implementation).
 - On May 22, Part 2 of the Invisible Achievement Gap (focusing on the experiences that impact educational outcomes among foster youth). Laurie Kappe reported that as a result of the convening for the report and the data

generated from both reports, Los Angeles is reforming the approach to dealing with education for children in care (increasing dedicated staff from 2 to 80)
