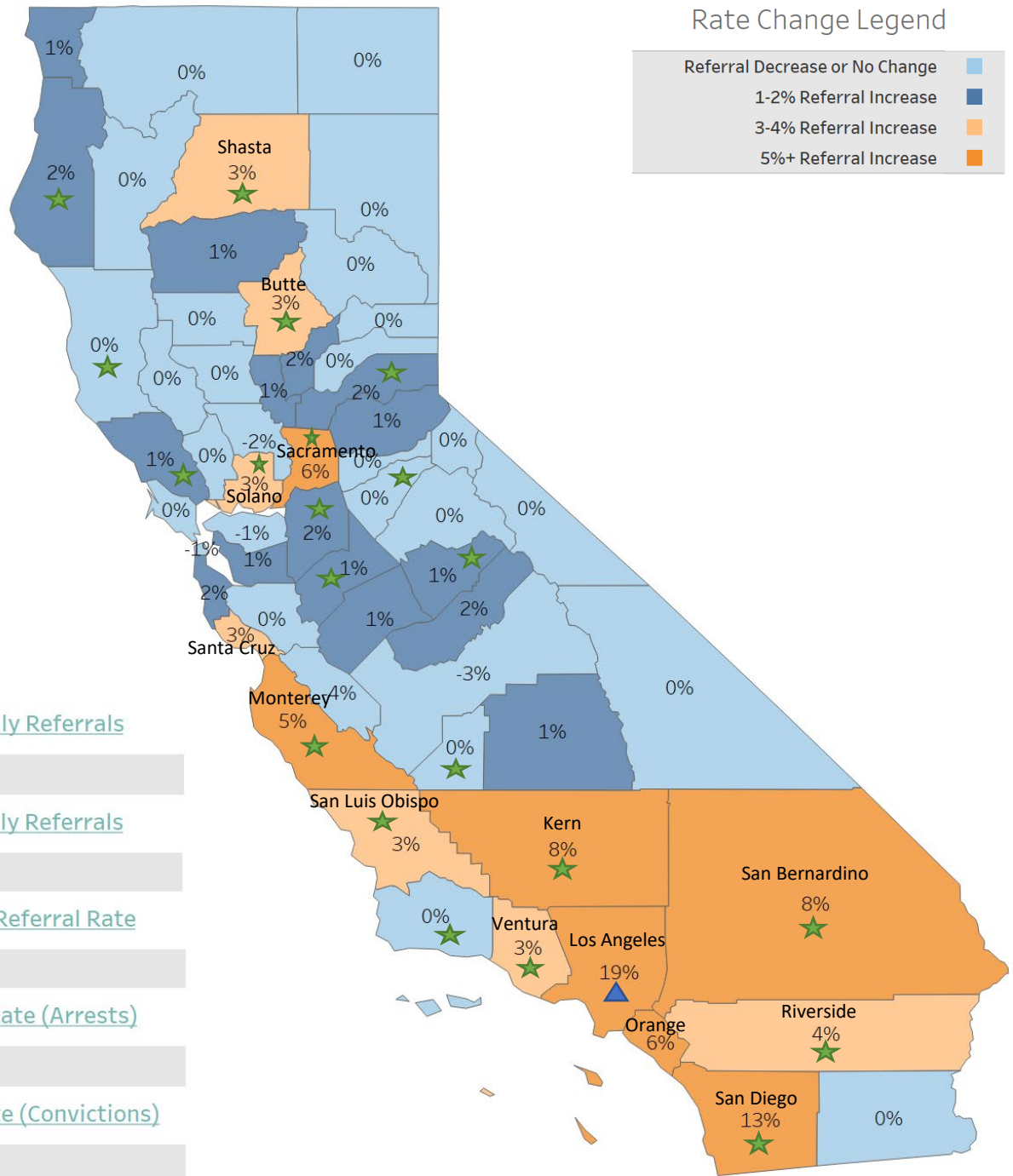

**3-Cohort Recidivism Rate** - Percentage based on the recidivism average of 3 discharge cohorts.

Discharge cohorts included felony ISTs who discharged during the following fiscal years: FY 2013-14, FY 2014-15, FY 2015-16.

**Recidivism Rate (Arrests)** - is based on the count of individuals arrested within 3 years following discharge [count of individuals (arrested)/# of discharges].

**Recidivism Rate (Convictions)** - is based on the count of individuals convicted for an arrest within 3 years following discharge [count of individuals (arrested)/# of discharges].
