

#### Highlights of a Few Investments Released

- \$9 million to fund a statewide direct deposit payment system for child care contractors effective January 2022
- Increase of CCTR, CAPP, CMAP, and Bridge slots
- Investments of (1) new construction and (2) repairs and renovation
- \$600 per subsidized child stipend anticipated to be released mid-September 2021



#### 2022-24 Child Care and Development (CCDF) State Plan

- Draft 2022-24 CCDF State Plan sent to Federal Office of Child Care (OCC) on June 30, 2021.
- Draft plan will be posted to CDSS website by end of September.
- OCC will notify CDSS of final approval including areas on noncompliance near the end of September.
- The 2022-24 CCDF State Plan is effective October 1, 2021, through September 30, 2024.
