# Action: Finalization of Recommendations and Items for Update to the Secretary

- The Alzheimer's Advisory Committee would like to convey to the Secretary that SB 48 is moving to the Governor's desk for signature.
- The Alzheimer's Advisory Committee would like to recommend all 15 recommendations.

### Dementia Standard of Care

This committee urges the Secretary to accelerate work in this area to ensure all components of comprehensive dementia care are advanced simultaneously, including:

1) By December 31, 2021, convene lead staff from CDPH and DHCS, as well as subject matter experts, to identify and compare existing standards of dementia care and those in development, focusing not only on detection and diagnosis but also on post-diagnostic care. The 10 CADCs are a vital partner in this effort, as are representatives of organized medicine in California.

2) Encourage DHCS to articulate the Population Health Management strategy for people living with dementia across all Cal-AIM initiatives

3) Identify funding opportunities to enable the Office of Medicare Innovation and Integration to explore alternative payment models that incentivize implementation of dementia standards of care, such as this <u>model framework</u>.

4) Support <u>SB 48</u> and the statewide rollout of Dementia Aware as national models at the forefront of dementia screening, early detection and timely diagnosis.

# Dementia Capable Workforce

The committee acknowledges this topic is inordinately complex – yet absolutely central to quality dementia care. Accordingly, the committee requests that the Secretary consider the following:

1) Convene a "Workforce Solutions Table" with representation from this committee to advise on issues related to Alzheimer's disease and dementia.

- a. Include representatives of state government, health and human services professions involved in dementia care, legislature, educational institutions, labor, and other stakeholders.
- b. Work with Department of Labor to determine which of the above job types/categories have the most acute shortages currently and projected deficits to prioritize new solutions.
- C. Review existing dementia curricula and either adopt or develop core dementia "basic training" to adapt and embed across all classifications rather than reinventing for each job type. Catalogue and assess existing model trainings and best practices including: HRSA 25 Modules (<u>https://bhw.hrsa.gov/alzheimers-dementia-training</u>), Alzheimer's Association <u>Dementia Care Practice Recommendations</u>, evidence-derived <u>EssentiALZ</u>, Center for Caregiver Advancement <u>IHSS training</u> curriculum, UCSF Dementia Ecosystem care navigator training, etc.
- d. Examine workforce solutions through the lens of a person with dementia and of caregivers who are likely to utilize home and community-based services, facility-based long-term care [nearly half of all nursing home residents have dementia] and hospitals/emergency departments (logging more than 1 million visits annually).

### **Caregivers**

The growing number of caregivers and the relatively small funding for caregiver-focused programs requires the State to be very efficient with caregiver expenditures. CDA should be the lead agency coordinating policy development and program implementation and oversight to ensure resources are used strategically and to leverage opportunities to increase services and supports. The Advisory Committee recommends that the Secretary:

1) In light of historic investments in the direct care workforce (more than \$800 million), consider dedicating all \$4 million in the CDPH budget for caregiver training and certification to work exclusively benefiting family/friend caregivers. We further suggest that this work be done in tandem with CDA's caregiver initiative funded at \$2 million to maximize the state's impact on this constituency.

- a. Make CDA the lead agency on family/informal caregivers and request that it:
- b. Develop a webpage for caregivers and agencies that serve them including a repository of caregiver information, services, programs, etc.
- c. Link to the Family Caregiver Alliance's Best Practice Caregiving website for accessing evidenced-based dementia caregiver trainings and interventions.

2) Proactively support expansion statewide of evidenced-based family caregiver training programs and interventions.

 Advise DHCS of the importance of formally incorporating family/friend caregivers into CalAIM documents to ensure, where appropriate and as available, caregivers are identified and documented in the medical records of those diagnosed with dementia.
Advise CDA, the lead agency for implementing the State's "No Wrong Door" expansion of the ADRC network, that the model should include protocols for assessing caregiver needs and connecting those individuals to local caregiver support programs. Encourage dementia training for ADRC staff. 5) Encourage CDA's Master Plan for Aging Equity Workgroup, in partnership with trusted community-based organizations, to highlight linguistically and culturally competent caregiver training to extend reach to underserved communities.

- The Chair would like to thank Darrick Lam for volunteering to join the CDPH on their Caregiver Training project.
- The Chair would like to commend the departments and agencies for all coming to the table and breaking down the silos that have existed, thereby promoting cohesive services for those with Alzheimer's disease and related dementias.
- The Chair would like to thank Debra Cherry and Janet Yang for their service on the Committee and note the work that has advanced related to mental health services.
