Eric Harris, Resources for Independent Living in Sacramento

Eric Harris was born in Berkeley, California and grew up in Sacramento. He attended the University of Arizona on a wheelchair basketball scholarship. Mr. Harris was selected as a member of the Under 20 USA Wheelchair Basketball Team that played in Brisbane, Australia. His team won the international championship, and he was selected as an all-tournament team member.

While in college, Mr. Harris focused on public policy and worked for United States Representative Barbara Lee (CA). While in Washington, he worked on policies relating to athletes with disabilities in school. After his experience in Washington, Mr. Harris attended the University of Oregon School of Law. In 2012, Mr. Harris worked at the Democratic National Committee and worked on general policy for the western region and disability policy throughout the country. He spoke to the college democrats at the Democratic National Committee in Charlotte, North Carolina about issues impacting students with disabilities. The next year, he interned at the American Association for People with Disabilities in Washington, D.C.

Mr. Harris returned to California and worked as a campaign staffer for U.S. Representative Barbara Lee in Oakland and as a staffer for Sacramento City Councilmember Allen Warren. He then worked for the California State NAACP as their only legislative advocate working at the state level. He started to work at Disability Rights California in 2019 as a legislative advocate. He worked in the Strategic Partnerships and Community Engagement Unit as a Special Advisor with Tho Vinh Banh from October 2020 to February 2021.

Mr. Harris has done community work with disability leaders, community members and elected officials throughout the country. He is a proud member of Phi Beta Sigma Fraternity, Inc. and attends Bayside Midtown Church in Sacramento, California. Mr. Harris is a member of the State Independent Living Council as a Governor Newsom appointee, and a board member of the Resources for Independent Living in Sacramento.

Patti Prunhuber, Justice in Aging

Michael Humphrey, Sonoma County IHSS Public Authority

Mike Humphrey is a recognized community leader and an accomplished executive manager, devoting the past 30 years to leading and administering not-for-profit and government social service programs.

In 2002, the Sonoma County Board of Supervisors appointed Mike to his current position as the Manager of the Sonoma County In-Home Supportive Services (IHSS) Public Authority. He previously served a 13-year tenure as the Executive Director of Community Resources for Independence (CRI), a not-for-profit organization providing advocacy and services to persons with disabilities in four northern California counties.

During his executive management career, Mike was responsible for developing innovative and creative programs, including emergency preparedness training for persons with disabilities and seniors, critical training opportunities for personal care assistants/home health aides, urgent substitute personal assistant services, home access modifications for persons with disabilities, outreach to Native Americans and other underserved populations, and others. He developed and managed multi-million-dollar budgets, administered the implementation of employer/labor agreements, oversaw the eligibility and enrollment of health benefits for over 500 employees, developed and managed contracts for providing program services and training opportunities, and provided staff leadership and support to a ten-member community advisory committee.

Due to his expert knowledge and lifelong passion of advocating and supporting programs and services that advance the rights and opportunities of persons with disabilities, Mike has been appointed to several prestigious statewide and local committees. His current service to the greater community includes appointments to the California's Olmstead Advisory Committee and the California Dept. of Health Care Services, Stakeholder Advisory Committee. She has extensive experience as a volunteer for older adults having worked with AARP as a District Liaison, Westside Pacific Villages as an "age-in-place" intern, and the Center for Healthcare Rights as a State Certified HICAP Counselor. At Iona Senior Services in Washington, D.C. she worked as an intern doing research on policy issues relative to "No Wrong Door" as well as, Age Friendly D.C. Her other volunteer work has been with veterans through the American Legion and Veterans of Foreign War Auxiliaries.

While a Gerontology student at the University of Southern California, she trained as part of a "Wicked Problems Practicum" on the development of Age Friendly Los Angeles, which morphed into the first ever "Age Friendly University". As a Champion for older adults, Corinne has been a featured speaker at the Los Angeles 9th City Council Districts "Senior's Celebrating Life" event and has presented at various other older adult events convened to encourage life enrichment for the elderly.

Corinne currently serves as a member of the California Department of Aging's, Aging and Disability Resource Connection Advisory Committee and is an appointed member on behalf of Older Adults, to the City of Ukiah Diversity/Equity/Inclusion Committee. Connie is committed to having a role in providing programs and services to ensure the best quality of life for older adults throughout California; using advocacy, community engagement, training and other resources, to insure their opportunity for independence and dignity.

Kathy Kelly, Family Caregiver Alliance

Kathleen Kelly is Executive Director of Family Caregiver Alliance, a national nonprofit organization that provides direct caregiver support services, public policy development,

research, and public awareness regarding family caregivers. As director, she oversees programs of the Bay Area Caregiver Resource Center, California policy collaborations, and the National Center on Caregiving. During her tenure, the organization has grown from a grassroots program to a national organization that provides leadership on supporting family caregivers with best practice interventions, public policy, state system development, and leading-edge research.

Eileen Kunz, On-Lok Lifeways

Eileen is the Chief of Government Affairs and Compliance for On Lok. In this role, she is responsible for policy, government and community affairs and regulatory affairs and compliance for On Lok. Eileen joined On Lok in 1986 as On Lok Replication Project Coordinator and was involved with the strategic direction of On Lok's national replication of the Program of All-inclusive Care for the Elderly (PACE) model since its inception and provided technical assistance to the initial PACE replication sites. She worked with federal and state policymakers to advance the model, culminating with the passage of The Balanced Budget Act of 1997, making PACE a permanent provider type under Medicare and a state option under Medicaid. She was instrumental in the formation of the National PACE Association and served as Deputy Director for NPA until 1998. During her tenure, she led the PACE Regulatory Integration Project to streamline the regulatory oversight of PACE in California, secured clinic and adult day health care center licenses from the California Department of Public Health and managed successful approval of PACE service area expansion applications and waiver requests from Centers for Medicare and Medicaid Services and State Medicaid for BIPA waiver requests including one of the first waivers to use community-based primary care physicians.

Eileen serves on the National PACE Association Public Policy Committee and on board of directors for the California PACE Association, or CalPACE. In 2009, Eileen received the Judy Baskins Volunteer Leadership award for her service to the National PACE Association in advancing the PACE model of care. She also serves on a number of state and local advisory committees related to improving services for seniors and persons with disabilities including the California Olmstead Advisory Committee and the San Francisco Long-Term Care Coordinating Council. She received her undergraduate degree in Social Welfare for the University of California at Berkeley and went on to receive her master's degree from the UC Berkeley School of Public Health in health policy and administration.

Sunny Maden, Family Member and Advocate

Sunny Maden, of San Gabriel Valley, is mother to Marc, who is responsible for her involvement with other families whose loved ones have developmental and intellectual disabilities, including wanting to be a part of the policy making that has affected Marc and others. Marc became a Lanterman Developmental Center resident in 1972. Sunny has been attending legislative hearings and has seized opportunities to become involved with local and statewide parent/family groups.

Sunny and her husband, Charlie, owned their own escrow company for many years. Charlie developed Alzheimer's Disease and, over the last 13 years, Sunny has been his primary caregiver.

Sunny is a board member for the Valley Fund Corporation. This fund partially supports the San Gabriel Valley Training Center/The Roland Center. The Center provides residential services for 38 people and employment opportunities for over 200 participants. Sunny also serves on the board of the CSHPCR, a family statewide group.

Shireen McSpadden, San Francisco Human Services Agency

Shireen has more than 25 years of experience developing policies and services to help ensure San Franciscans thrive as they age. Shireen is the Executive Director of the Department of Homelessness and Supportive Housing for the City and County of San Francisco. She served as the Director of the San Francisco Department of Disability and Aging Services from 2016 to 2021.

She is a board member of the California Association of Area Agencies on Aging and is an alternate board member, representing California, for the National Association of Area Agencies on Aging.

Shireen earned a Master's degree in nonprofit administration from the University of San Francisco.

Peter Mendoza, Consumer Advocate

Peter Mendoza brings to the California State Independent Living Council four decades of disability advocacy experience. His work in advocacy began at the age of 17, when he testified in front of the California State Legislative Subcommittee on the need for services and supports for people with disabilities for the Regional Center System. Peter became a tireless advocate for accessible transportation, housing, in-home support services, and employment for people with disabilities. His advocacy was recognized by President

George H. W. Bush, who invited Peter to witness the historic signing of the Americans with Disabilities Act of 1990.

In 2001, Peter was appointed by California Governor Gray Davis to the State Council on Developmental Disabilities and was subsequently reappointed by Governor Arnold Schwarzenegger. Peter served as both Vice Chair and Chair of the Council during his tenure. Since leaving the Council, Peter served on the Tarjan Center Community Advisory Committee, the California State Rehabilitation Appeals Board, the City of Berkeley Commission on Disability, and on the Board of Directors for Easy Does It Emergency Services in Berkeley. Peter is still very active, currently serving as Chair of the Golden Gate Regional Center Self Determination Community Advisory Committee, Consumer Advocate for the California Olmstead Advisory Committee, member of the California State Independent Living Council as appointed by Governor Edmund G. Brown Jr., in addition to working at Marin Center for Independent Living as their Director of Advocacy and Special Projects.

Peter lives in Elk Grove with his wife, Jennifer, and their dog, Latte. His phone rings frequently with calls from people with disabilities and their families requesting his advocacy expertise and policy advice.

Christina Mills, CA Foundation for Independent Living Centers

Christina Mills has served as the Executive Director of the California Foundation for Independent Living Centers (CFILC) since 2017, and she has over 20 years of disability rights and independent living center services experience.

As Executive Director of CFILC, Christina is responsible for seamlessly implementing six statewide programs while also building the capacity of her Independent Living Center members. Earlier this year, Christina launched California's first cross-disability not-for-profit Disability Disaster Access & Resources (DDAR) program. The DDAR pilot program is a partnership between CFILC and Pacific Gas and Electric (PG&E) that provides people with disabilities services and resources before, during, and after a Public Safety Power Shutoff (PSPS).

Christina recently served as an appointee of the California Master Plan for Aging (MPA), Stakeholder Advisory Committee that was charged with developing a ten-year plan focused on creating a California for All. Kimberly Mills has over 30 year of experience providing social services to youth, adults and their families. Kim is the founder and CEO of A Better Life Together, Inc.(ABLT) to supports individuals with intellectual and developmental disabilities to realize their dreams. Kim is the proud mother of 3 amazing sons Antoine, Naeem, and Jalení. Naeem passed away unexpectedly in 2016 at the age of 22 due to a seizure. Naeem’s death reignited Kim’s passion to continue advocate for the rights of everyone. Kim believes everyone has a purpose in life and it is our responsibility to help individuals find their purpose and fulfill it. Kim has been working to close the disparity gap amongst people with intellectual and developmental disabilities of color who are underserved. Kim is originally from Ohio and holds a Master’s degree in Community Counseling from Kent State University.

Lydia Missaelides, Alliance for Leadership and Education

Lydia has enjoyed a 35-year career in public policy and program development in aging, mental health, and disabilities. She served for 30 years as Executive Director for the California Association for Adult Day Services (CAADS). Beginning in 2003, she served concurrently also as the Executive Director of the Alliance for Leadership and Education (ALE), the public benefit and research arm of CAADS. She has since retired from CAADS to devote her time to her work with ALE.

Lydia was appointed in November 2019 to serve as a member of Governor Newsom’s Long-Term Services and Supports Subcommittee for the Master Plan for Aging and an appointed charter member of the California Health and Human Service Agency’s Olmstead Advisory Committee. Jeanee Parker Martin, President & CEO of LeadingAge California and Vice Chairman & Principal of The Corridor Group Holdings and subsidiary companies, is a leader in the strategic development of innovative healthcare programs and aging services.

Active in health service planning, development and delivery of care for over 30 years, Jeanee has assisted organizations around the world — spanning the U.S., Central and

South America, Thailand, and Turkey. Jeannee was the first and only home care and hospice expert to consult with the WHO Global Programme on AIDS, and for the U.S. Department of State in South Africa. Jeannee has advised some of the largest U.S.-based publicly-traded companies and non-profit healthcare organizations by providing them with effective strategies for growth and development, mergers and acquisitions, and operations and finance. Jeannee has served on 17 boards of directors and is sought out by boards and executive teams for her leadership and understanding of strategic, financial and governance matters.

The former Chief of Social Work for Rancho Los Amigos National Rehabilitation Center, he continues in his role as Co-Founder and Executive Director of The Rancho KnowBarriers Life Coaching Program, providing leadership to programs designed to teach critical life skills to people living with a disability.

He has received many awards for his work, including The California Governor's Committee on Employment of Disabled Persons, Employee of The Year and Rancho's highest honor, The Amistad Award. He is dedicated to improving the quality of life for individuals living with a disability by empowering them to return to work and full community reintegration. He is also passionate about developing programs to prevent youth violence, a leading cause of spinal cord injury.

As the current President of the California In-Home Supportive Services Consumer Alliance, she advocates on issues affecting both seniors and persons with disabilities both at the local, State, and Federal levels. Being involved with other state organizations has helped to broaden her perspective and identify opportunities for engagement.

When not busy with her volunteer work, she dedicates her time to her very supportive family, her husband, three married children and seven grandchildren.

Kate Wilber, USC Center for Long-Term Care Integration

Dr. Wilber's research has focused on improving the quality of life of people with chronic physical and mental health conditions, by improving the formal health and long term care delivery system. Her work on collaborative relationships among providers has examined cost effectiveness and health outcomes of different service delivery structures.
