## 1) Call to Order: Welcome, Committee Member Updates, and approval of minutes

### Home and Community-Based Services (HCBS) Spending Plan

American Rescue Plan Act (ARPA) provides qualifying states with a temporary 10 percentage point increase to the federal medical assistance percentage (FMAP) for certain Medicaid expenditures for HCBS programs.

California's HCBS Spending Plan was approved by CMS on January 4, 2022 and may spend these additional federal funds on programs to support through March 31, 2024.

### • HCBS Spending Plan: Dementia Aware

Funding: \$25 million enhanced federal funding, one-time.

Lead Department(s): DHCS, with California Department of Public Health (CDPH) and California Department of Health Care Access and Information (HCAI).

Investments to improve rates of dementia screening to ensure early detection and timely diagnosis, while also connecting individuals and families to community resources.

Provider training in culturally competent dementia care.

Referral protocol on cognitive health and dementia.

Promote use of validated tools, training, and referral protocol.

Make continuing education in geriatrics/dementia available to all licensed health/primary care providers.

Aligns with SB 48: Medi-Cal: Annual cognitive health assessment.

### • <u>Dementia Awar</u>e: Contract

DHCS is contracting with University of California, San Francisco.

UCSF subcontracting with several other UCs (UCI, UCD, Harbor UCLA, UCLA Division of Geriatrics, UCSD).

Leverages necessary expertise in both dementia care and screening implementation in primary care practices.

Training available for Medi-Cal providers by July 1, 2022.

### Medicare Annual wellness Visit (AWV)

Medicare covers yearly "wellness" visits to develop or update a personalized prevention plan.

Detecting cognitive impairment is a required element of Medicare's Annual Wellness Visit.

The Existing Alzheimer's Association Cognitive Assessment Toolkit is intended for physicians to use during the Medicare AWV. These cognitive assessment tools are used to identify individuals who may need additional evaluation.

If a physician detects cognitive impairment at an AWV or other routine visit, they may perform a more detailed cognitive assessment and develop a care plan during a separate visit.

### • SB 48: Medi-Cal: Annual cognitive health assessment

SB 48 establishes an annual cognitive health assessment as a Medi-Cal benefit for beneficiaries age 65 and older if they are otherwise ineligible for a similar assessment as part of the Medicare Annual Wellness Visit.

Pending legislative appropriation, Medi-Cal providers will be eligible to receive payment for this Medi-Cal benefit, for Medi-Cal-only beneficiaries, if they:

- -Complete cognitive health assessment training, as approved DHCS
- -Use one of the validated tools recommended by DHCS.

### • IHSS Career Pathways Program

Focuses on building provider knowledge and skills to manage and increase the quality of care for IHSS/WPCS recipients.

This program's goals are to offer skill building, professional development, personal growth, and to promote a competent, stable and diverse workforce to improve access, equity and quality.

The program will not offer an academic degree or professional licensing. Providers will receive certificates of completion for all courses. All IHSS and WPCS providers who have

completed provider enrollment are eligible to participate in the Career Pathways program.

### California's HCBS Spending Plan

Direct Care Workforce (non-IHSS) Training & Stipends: \$150 million.

A Multi-Pronged Approach: Support and Strengthen HCBS Workforce
 High quality training, stipends and initiatives, opportunities for advancement, evaluation, leadership learning and innovation.

# 6) Introduce for future discussion: impact of social isolation for individuals in long-term care and congregate settings

Darrick Lam, Vice Chair; Committee Members

• The Vice Chair provided information about the impact of social isolation on individuals with dementia during the pandemic and suggested that a small group be convened to discuss future presentation. Members who agreed to participate in that discussion are: Darrick Lam, William Mobley, Dolores Gallagher Thompson and Jared Giarrusso.

### 7) Finalize Recommendations and Items for Secretary Update

- The Chair would like to acknowledge the Administration on its implementation of the Master Plan for Aging and the useful and informative resources being provided.
- Barbra McLendon, Alzheimer's Los Angeles, wants to make the Committee and Administration aware of its budget request for \$25 million for family caregiver training

funds to CBOs. Alzheimer's LA appreciates the funds already included in the budget, but it is not enough. This request would expand access to underserved and rural communities using evidence derived training.

- Meg Barron (member) would like to note the Alzheimer's Association's support for the CADC request for an additional \$2 million in funding.
- Dr. William Mobley (member) would like to stress the importance of timing on all of the Alzheimer's activities. He believes we will have a treatment for Alzheimer's in 3-5 years, and we will have 600,000 Californians needing to be diagnosed and properly treated. The good news is that we are getting ready for it, but need to emphasize the urgency around current Alzheimer's activities. There is also a need for primary care physicians (PCP) to get training and educated on diagnosis, screening and treatment of Alzheimer's. He would like the Administration to consider ways to incentivize PCP training and screening for appropriate diagnosis.
- Andrea Robert (member) would like the Administration to consider that while there are significant resources going towards Alzheimer's public awareness campaigns to reach Black and Brown communities, we need to ensure that the funds are reaching those communities and there is currently a disconnect. The MPA has oversight mechanisms, perhaps need to look more closely at them.
- David Johnson, Director of the California Alzheimer Disease Center (CADC) in the East Bay, requests on behalf of the 10 CADC's around the state for an increase of \$2 million for the CADCs. Mr. Johnson requests the Secretary to consider supporting the request. The current request would enhance training opportunities for clinical students and fellows to enter the dementia healthcare workforce by providing new training opportunities in the state network of CADC. The request builds on training efforts that are happening in IHSS and other home care worker areas.
- Jared Giarrusso, Alzheimer's Association presented on SB 861 and AB 1618, which he
  believes are in alignment with Administration's efforts. For AB 1618, the bill would
  expand the expertise on the Alzheimer's Advisory Committee by expanding the number
  of members from 14 to 20 members, and expanding the diversity of its members. Due
  to the short amount of time, a subcommittee was formed to look at the Committee
  Composition. Individuals who volunteered to serve on this subcommittee include:
  Catherine Blakemore, Andrea Robert, Pam Montana and Barbara McLendon and Jared
  Giarrusso.
