The goal of the Elder and Disability Justice Coordinating Council is to increase coordination and develop recommendations to prevent and address the abuse, neglect, exploitation and fraud perpetuated against older adults and adults with disabilities. And with that I am so happy to welcome director Susan DeMarois of the California Department of Aging.

13:02:43 >> Thank you, Mariya. And good afternoon, everybody. Welcome back to meeting number 2. I'm so glad you all think it's worthwhile enough to come back a second time. And I know that for many of the members of this committee, and I'm going to call you out by name, you haven't been resting on your laurels since we last met.

13:02:59 We've been working busily with the equity framework and the landscape group. And I want to thank Vivianne, Nina, Sherry, Liz, Diane, Howard, Astrid, Claire, who have all been working on the equity workgroup.

13:03:41 And we also have Lisa, Andrea, Akiles, Jaime, Edward, Scarlet and marty also working on the landscape group. We have a full agenda today. I want to thank especially Amanda Lawrence who has been staffing all of us and pulling together our presenters and lots to talk about today, looking forward to diving into the agenda. But first I want to thank Phil Ferrari for joining us. I'm so glad that Phil, who is the senior assistant attorney general of the criminal section of the division of Med

13:03:47 Is joining today to bring a message from the Department of Justice. Welcome, Phil.

13:04:17 >> Hello. Thank you very much. I'm very happy to be here. I am senior assistant attorney general for part of the California attorney general's office. And that means I have the privilege of supervising prosecutors who are located throughout the state working on matters involving older and dependent adults, both neglect and financial or physical abuse, and also prosecuting cases involving efforts to defraud the Medi-Cal program.

13:04:33 And while I work on the criminal side of matters, I have a counterpart who oversees equally committed and talented team of attorneys who pursue civil enforcement actions against those who would try to defraud the Medi-Cal program.

13:04:57 So protection against elder abuse and neglect is a fundamental part of our mission. It's a priority for us, it's a priority for the attorney general. And we are very proud to be part of this Elder & Disability Justice Coordinating Council, which we know is going to enhance our collective abilities to care for and protect some of our most vulnerable residents.

13:05:30 One thing I want to stress from our perspective is we know very well that protecting against elder and dependents abuse requires a coordinating and collaborative response, and for us it can be as simple as stating that we can't act upon that which we don't know. We have these great tools, resources, experience, expertise, but unless we get referrals, from our partners who we very literally depend upon in state and local government, law enforcement, the public in general.

13:05:45 To let us know when there are problems and give us the opportunity to put those tools to work, we can't achieve anything. I wanted to just really briefly mention some of the recent work that we have done here in the area of elder abuse.

13:06:18 Just a couple of examples. That sort of illustrate both the range and the severity of some of the conduct we are called upon to address. Just yesterday in Los Angeles County, we secured a felony elder abuse conviction against a former director of nursing who had stolen personal information from a resident in a home and opened multiple credit accounts and rang up over \$70,000 in charges.

13:06:52 Just a few weeks earlier, again in Los Angeles, we secured following a jury trial, a conviction against certified nursing assistant for both elder abuse and felony sexual battery against an elderly stroke victim who was put into his care. And then a couple months before that in San Diego, we secured a significant prison sentence against San Diego caretaker whose conduct included not just stealing money and jewelry from the people who were put into his care.

13:07:27 But also committing acts of sexual assault against three elderly dependents as well. In not one of those cases could we have succeeded without critical assistance from our partners in state agencies, local law enforcement, local government, and so while at DMFEA we are proud of the role we play, we know it's a limited role, and we know we are very dependent upon our partners and the work of so many others like those, our partners at CalHHS and others, state and local entities.

13:07:48 And that's one of the reasons why we are so supportive of the collaborative and multidisciplinary approach which we know this council will foster. The last thing I wanted to mention is I believe my colleague deputy attorney general Megan Anderson is with us today. She's been involved with this council since the very beginning. And we are very grateful for her work.

13:08:00 And we both look forward to advancing the work of the council together. So thank you so much. And again, I'm just so happy to be here today.

13:08:11 >> Thank you so much, Phil. Thank you for being here. And unfortunately, thank you for sharing those real life examples very very current to motivate our work today and in the months to come.

13:08:34 For the next slide, as we're starting to get out and about, I've been hearing from our partners with area agencies on aging, our aging and disability resource connections, our county partners about activities that are underway for June 15th world elder abuse awareness day.

13:08:58 So I want to thank all of you who are part of today's webinar who are planning activities at the local level to engage and collaborate as we just heard from Phil, I've heard great examples where counties are bringing in the legal sector and elected officials, Health and Human Services, and advocacy groups. So we encourage you in that work.

13:09:28 And we also start, starting next week, older Americans month at the start of May. So I know many of you are working on a range of activities there to educate the public as well. So this is our agenda for today. I want to thank everyone who is contributing. It was very important for all of us who plan the agenda together today that we heard from a number of perspectives and voices.

13:09:52 So you'll see that we'll move along quickly as we bring in a variety of stakeholder perspectives and expert opinions. And I will start with the first. We have a number of state partners and committee members who -- we're going to welcome and introductions first. Oh. We're going back.

13:10:29 So we'll go ahead and do the roll call, there. And instead of for the sake of time, we can go ahead to the next slide there. And we'll just pause for a moment to look at all the stakeholder members. We aren't going to be taking a verbal roll call, but take note of all who are part of this coordinating council. 13:10:46 With that, we want to make sure that any member of the coordinating council who is representing a state entity has an opportunity to say hello and to offer any updates that you'd like to bring from your agency or your department.

13:10:59 And we can go ahead. I'll just look at my screen, and I'll call as I see faces, not in any order of priority. We'll go ahead and start with Leslie Morrison, is there anything you'd like to add, Leslie?

13:11:03 >> Nothing. Just really happy to be a part of this group.

13:11:11 >> Great. Thank you for representing the Department of Developmental services. Next I see Dr. Otogon. Is there anything you would like to say?

13:11:29 >> Good morning, everyone. Just hoping everyone's doing well. As you know, although in general, COVID has improved, cases have been creeping up. So we're watching the numbers carefully, hoping everybody stays safe. That's it.

13:11:36 >> Thank you for being here. And the Claire Ramsey is next on my screen, from the Department of Social Services.

13:12:07 >> Hi. Thanks so much. We actually have two announcements. First I'm really excited and sad to announce that Rutledge has been appointed at the California Department of Rehabilitation. I say sad for us, but we are very excited for Kim and know she's going to do a wonderful job. She has been serving as our APS program liaison for the last few years and has done a wonderful job and was instrumental in getting this committee up and running.

13:12:37 So we want to thank Kim, congratulate her and let you all know that we will be looking for a new APS program liaison. So if you know good people, if you think you are a good person, please feel free to e-mail me. I'll put my e-mail in the chat. And I wanted to mention around world elder abuse awareness day, hosting an event on June 2 from 2 to 4 and it will be an in person and virtual event, a hybrid event.

13:12:58 We are going to do a reception to follow for the in-person attendees. We are partnering with CDA, the long-term care ombudsman, California commission on age, empowered aging, C4A, the California elder justice on collision and the child and family policy institute of California. We are super excited to host this event again and have some in person and online.

13:13:10 We'll have more details to come. And if anyone is interested in that, please also let me know. So thank you again. Thanks, Susan, for letting me speak.

13:13:24 >> Thank you, Claire. We join you in congratulating Kim and thanking her. She was part of this from the outset, and she's been an active, active leader of this advisory council since before it was even formed and through today.

13:13:35 So we will miss Kim in that role. But we're very happy to congratulate her. I see Vance Taylor next.

13:13:51 >> Thank you. I wanted to provide an update on two programs, the first is the elder abuse program we have. And the purpose of the program is to continue to enhance the safety of elder and dependent adult victims of abuse.

13:14:25 And really to bridge that gap between elder justice service providers and victim service providers. We're in the fourth year of a five-year funding cycle. And we're up for competitive in fiscal 23/24, expect that to be on our website. The program funding is about \$4.6 million. And individual subrecipient allocation is up to \$217,000.

13:14:48 The second program is our specialized emergency housing program. And that's to expand emergency shelter and emergency housing assistance to provide supportive services for victims of crime with specialized needs, including older adults and individuals with disabilities and individuals from the LGBTQ+ community.

13:15:21 That may not be served through traditional shelter and programs. Those individuals will be allowed to choose which supportive services best fit their needs. And the program was designed with older adults, victims in mind. That RFP is out now. Proposals are due Monday, May 23. And the program funding is \$9.6 million, with individual subrecipient allocations being up to \$300,000.

13:15:28 So I wanted to make sure folks are aware of that and take advantage of those programs.

13:15:39 >> Thank you, Vance, for that update. We appreciate it. I see that we're also joined by Fay Gordon, representing the federal administration on community living.

13:15:41 >> Hi.

13:15:43 >> Hi, Fay, welcome.

13:15:57 >> Thank you so much. Just happy to be here, and as always, California continues to be such a model. I always love hearing people say we're interested in a master plan on aging or interested in this. And it's like California's already doing these incredible councils.

13:16:09 And just available if anyone needs anything from ACL's side on older American month activities. We have preparation, and I'm here to be helpful. Thank you.

13:16:44 >> Thank you. And Darci Delgado representing secretary gally in the California Health and Human Services agency. Welcome, Darci. And did I miss anybody from the state of California? Susan Rodriguez with the Department of Aging office of the long-term care patient representative and blanca Castro, long-term care ombudsman are with us. Lynda. Welcome, Lynda.

13:16:58 Please feel free to share any updates if you'd like. Aaron, welcome. Aaron carruth re s.

13:17:15 >> Thank you so much. Council on Developmental Disabilities. One really exciting update that didn't come to pass, but the state council along with others sponsored legislation to have \$1.4 billion available for rental assistance for older Californians and Californians with disabilities.

13:17:27 That number is a big number. It wasn't the biggest number as it relates to housing but the conversation's related to housing are happening among the governor and top leadership with the legislature.

13:17:47 In the end this is not going forward, but I do want to acknowledge the success of this failure, because it was an accomplishment unto itself to have a legislation behind rent supports, which we know are critically needed, but leadership has been reluctant to really commit California in that way.

13:18:01 So we took a run at it this year, wasn't successful. We'll see what next year brings. Thank you.

13:18:04 >> Hi, Susan.

13:18:12 >> If anybody elsed to make comments, otherwise we'll go ahead and move onto our -- yeah.

13:18:26 >> So, I have a couple. Southern California.

13:18:40 >> All right, everybody. Looks like we may have lost Susan. She's kind of frozen up there. So we'll give her a minute to reconnect and just see if there's anybody else from the stateside that wants to share updates.

13:19:11 >> Yes, hello, Bruce Lim, health care services. Audit and investigations serves athe state's dedicated program integrity unit. We work very closely, hand in hand with Phil Ferrari, Jennifer, who serves as the state's Medicaid fraud control unit. Obviously the more eyes and ears on the ground to identify potential areas of concerns with regards to patient harm and elder abuse, the better.

13:19:34 We also work very closely with local law enforcement in the event areas of concerns are identified. And finally, DSS, we are proud to serve as a partner with DSS as the designated investigative body for this state's in-home supportive services program. So pleased to be here. Thank you.

13:19:46 >> Thank you so much. Last call for updates from our state members. Going once. Going twice. All right. Let's move to our next agenda item.

13:19:57 Stephanie, I apologize, I'm not going to do you justice in an introduction today. I don't have any notes in front of me as I step in for Susan. So I am just going to spotlight you and let you.

13:19:58 >> I'm back, Mariya.

13:19:59 >> All right. Great.

13:20:28 >> I'm so sorry, I sot goth kicked off. I'm traveling today. So just in time to introduce my colleague, Stephanie welch, the deputy secretary of behavioral health with the California Health and Human Services agency. Thank you, Stephanie, for joining us today. Stephanie has been an instrumental leader in the governor and the secretary of Health and Human Services care court initiative that's moving forward through the legislature and the budget process.

13:20:39 And Stephanie's generous enough to provide all of us with an overview and to allow time for question and answer from the audience. So welcome, Stephanie. Thank you for being here.

13:21:00 >> Absolutely. It's been on my list of things to do to actually observe this particular council. For those of you who don't know me, obviously I'm the deputy secretary of behavioral health. I'm a social worker by training. And I've been working in this field close to 25 years.

13:21:15 So in different positions, representing the counties, working at the state level, representing CBOs. And so it has really been my honor to come and work for secretary Gally and support this administration's vision for transforming the behavioral health system.

13:21:43 So let's go to the next slide. I'm going to take some time. I know, I want to keep my slides to 15 minutes so we have time for discussion. So I might not hit all the items on the slides. But you have them. And I thought, before we talked about the specifics with care, it would be important to put it in the context of where we are now that we're moving towards the end of the first term of this administration, what have we accomplished, what are we trying to accomplish.

13:22:01 This governor came in and said he was going to make behavioral health across the life span and for all Californians a priority, and so it really has been incredible after all this time working in this space to move so fast and furiously on so many different investments.

13:22:28 And I think there's just a real critical recognition, frankly a recognition that really was led by the legislature for so many decades but a recognition among the administration that we have critical infrastructure challenges in behavioral health that are rooted in decades of stigma and discrimination towards people living with behavioral health challenges.

13:22:38 And so we have a lot of work to do. But I'm going to hit some of the highlights before we go into care in the next couple slides.

13:22:59 So we recently published a behavioral health needs assessment through our Department of Health Care Services. And I wanted to highlight a couple of things, because the needs assessment really frankly is cemented what we already knew, and isn't an end all be all when it comes to data analysis on the problem.

13:23:15 But there were some things that were really striking in the data. One was we need a comprehensive approach to crisis services. And I'm sure that this is a space in which you talk about that particular issue quite a bit.

13:23:51 Similar to some comments that were at the top of the hour, we have just a dirth of options, especially for people with consistent mental illness, to long-term housing and residential care facilities. On the kids side, we simply don't have a variety of treatment option for children and youth. This is particularly profoundly missing amongst children who need treatment for substance use disorders.

13:24:04 We have not caught up to what we know in terms of the evidence around community defined evidence and culturally appropriate practices. So we really have a lot of work to do to advance equity.

13:24:27 And then lastly, another issue that I'm sure you talk about quite a bit in this space is that for individuals who are justice involved, there's an incredible amount of enormous challenges, some of them bureaucratic, when it comes to accessing housing, having economic justice and access to physical health care.

13:25:01 Next slide. So I'm going to talk a little bit about some of the things that we did last year before I talk about some of the proposals this year, including care court. This slide really emphasizes this year's investment in our CalAIM justice package. But I can't really underscore how the California advancing and innovating Medi-Cal program, which I'm sure you talk about in this space, has really and will change our behavior, our behavioral health delivery system into one that hopefully i

13:25:33 And seamless for individuals who may be experiencing a more mild to moderate condition, and unfortunately that condition deepens and becomes more severe, and they have to access specialty mental health care. And we think that in the long-term this not only will create a more outcomes-based system, but a workforce that is having the opportunity to spend more time caring for people than they have filling out paperwork, et cetera.

13:25:52 SoCal aim would be a different day all together. But it really is the backbone of changing our ability to provide high-quality care to at least here in California, all of our Medi-Cal beneficiaries. The other one, which is really important, and related to care court is our behavioral health continuum infrastructure program.

13:26:17 And the community care expansion program, which you probably have talked about both of these. Together these two programs are bringing \$3 billion to invest in community-based care. So care facilities, as well as residential placements, as we recognize some of our most vulnerable and high needs high risk populations really need to be in long-term residential care.

13:26:33 And then we're really excited in a couple of months to fully launch our new peer support service benefit in Medi-Cal, which I think will go a long way in terms of providing wrap around services to support people with high needs to live in the community.

13:26:58 Next slide. So another project I really wanted to emphasize, it's also kind of part of this larger conversation we're having today about the whole crisis care continuum, care court being on that continuum. but Cal hope is a crisis counseling program that we actually started or DHCS launched in response to our California wildfires.

13:27:17 And really grew the program under the pandemic. And we will be not only really investigating how to use that in a way that can republican reach and serve all Californians, but also how it relates to implementing our 9-8-8 transition.

13:27:26 So, again, bottom line, it's really about being able to create more access and support for people around the state.

13:27:29 Next slide.

13:28:00 So that was the year before. And so now we focus on this year's investments. First we really did go through a process after being frankly after doing this work for a long time, feeling extremely blessed of having so many funding opportunities. We didn't mention the \$4.4 billion going into our kids and youth behavioral health system to really transform how young people access care in a hope that they will access it sooner. And a more timely fashion.

13:28:15 Access to high-quality care, so we can address behavioral health issues early on, and they don't progress and potentially create unfortunate or negative outcomes for those who have untreated mental illness as adults.

13:28:43 But we really sat down and thought, okay, we really want to double down. Many of these themes are themes that are consistent with the master plan on aging but really wanted to double down on addressing the needs of those with the most serious mental health challenges across the agency that also meant that doubling down on individuals who are justice involved and simply don't have equal access to services, immigrants, children and our aging population.

13:28:59 And I think the lead behind this really is, and I will speak for our work that we do in behavioral health and intersection with criminal justice and homelessness, is that we believe with the right services and supports, that anyone can live in the community.

13:29:18 I DON'T WANT TO SEE MY POPULATION TO END UP IN JAILS AND STATE HOSPITALS AND EVEN IN OUR CORRECTIONAL SYSTEM HERE AT THE STATE LEVEL.

13:29:46 WE REALLY KNOW HOW TO DO IT, WE GOT TO FIGURE HOW TO GET IT DONE AT THE LOCAL LEVEL. NEXT SLIDE? SO, COUPLE OF THINGS THAT ARE REALLY GOING TO ASSIST WITH THIS. FIRST WE ARE GOING TO BE PURSUING CREATING A MEDI-CAL REIMBURSEMENT BENEFIT FOR MOBILE CRISIS, REALLY EXCITED ABOUT THIS.

13:29:59 LOTS OF DIFFERENT MODELS, MULTIDISCIPLINARY MODELS, THINGS LOOK DIFFERENT ON COMMUNITY BY COMMUNITY BASIS, AND DOUBLED DOWN MAKING INVESTMENTS.

13:30:18 LAST YEAR WE INVESTED 150 MILLION IN INFRASTRUCTURE, VANS, ET CETERA. EXCITED TO SEE HOW THAT FITS INTO THE LARGER SCHEME OF INCREASING ACCESS AND GETTING TO PEOPLE SOONER TO PREVENT CRISIS IN THE FIRST PLACE.

13:30:43 OUR PATH PROGRAM IS REALLY GOING TO GIVE US ADDITIONAL RESOURCES TO REALLY ADDRESS THE SOCIAL DETERMINING OF HEALTH, AND DOUBLE DOWN, WE BELIEVE EVEN IF PEOPLE HAVE COMPLEX NEEDS THEY CAN GET THE WRAP AROUND SERVICES AND SUPPORTS THEY NEED IN ORDER TO LIVE SUCCESSFULLY IN THE COMMUNITY.

13:31:11 EXCITED ABOUT THAT AS PART OF THIS YEAR'S AND ONGOING EFFORTS. NEXT SLIDE? I WOULD WILL REMISS, WE ARE CERTAINLY GETTING A LOT OF FEEDBACK IN CONVERSATIONS AROUND CARE COURT AROUND THE WORKFORCE CRISIS AND BEHAVIORAL HEALTH. THIS \$1.7 BILLION INVESTMENT IN THE CARE ECONOMY WORKFORCE WHICH IS REPRESENTATIVE OF QUITE A FEW BEHAVIORAL HEALTH PROVIDERS.

13:31:32 CERTAINLY PEOPLE WHO WOULD BE WORKING IN THE SPACE OF SUPPORTING PEOPLE TO LIVE INDEPENDENTLY IN COMMUNITY BASED SETTINGS. IT'S REALLY THE OVERARCHING THEME OF THIS AS WELL AS HELPING US GET TO MULTILINGUAL AND DIVERSITY WE NEED SO OUR STAFF AND WORKFORCE LOOK LIKE THE PEOPLE THEY ARE SERVING.

13:31:55 SO, REALLY EXCITED ABOUT. IT'S NOT GOING TO IMMEDIATELY RESULT IN MORE SKILLED WORKFORCE, BUT EXCITED ABOUT THIS INITIATIVE AS WELL AS THIS BUILD ON OUR \$800 MILLION DOLLAR SUPPORT FROM LAST YEAR.

13:32:19 COUPLE THINGS TO POINT OUT HERE, REALLY WANT TO EMPHASIZE BEHAVIORAL HEALTH BRIDGE HOUSING, TALK ABOUT IT AS PART OF CARE COURT, THIS REALLY IS \$1.5 BILLION TO ADDRESS IMMEDIATE HOUSING AND TREATMENT NEEDS OF PEOPLE EXPERIENCING OR AT RISK OF HOMELESSNESS WITH SERIOUS BEHAVIORAL HEALTH CONDITIONS.

13:32:36 INTNDED TO GIVE FLEXIBLE GENERAL FUND DOLLARS, SO THAT WE CAN WORK WITH PROVIDERS TO SUPPORT THEM TO HAVE THE ADDITIONAL CLINICALLY ENRICHED SERVICES TO SUPPORT SOMEBODY LIVING IN THE COMMUNITY.

13:33:02 ALSO, SOME CREATIVITY FOR THE COUNTIES. THESE ARE FUNDS THAT ARE AVAILABLE OVER THE NEXT FIVE YEARS AND PRIORITIZING FUNDS FOR CARE COURT RECIPIENTS. NEXT SLIDE. SO, SPEAKING OF CARE COURT. YOU KNOW, CARE COURT, WE STARTED THINKING ABOUT A PROPOSAL FOR CARE COURT LATE LAST FALL OVER THE WINTER.

13:33:19 WE ARE REALLY TRYING TO FOCUS ON DOING SOMETHING THAT REALLY WAS A NEW APPROACH. AND I THINK MANY OF US FOR THE LAST SEVERAL YEARS HAVE BEEN WORKING ON INITIATIVES TO TRY TO SERVE, IN PARTICULAR THE JUSTICE POPULATION.

13:33:52 AND THE SECRETARY DOES A BETTER JOB AT EXPLAINING THIS. BUT MANY OF US SAID PEOPLE SHOULD NOT HAVE TO ENTER THE BEHAVIORAL HEALTH SYSTEM THROUGH THE JAIL SYSTEM OR REPEAT HOSPITALIZATIONS, HOW COULD WE POSSIBLY GET AND OFFER SERVICES TO PEOPLE BEFORE THESE NEGATIVE THINGS HAPPEN THAT REALLY RESULT IN INCARCERATION AND ULTIMATELY MANY CASES CONSERVATORSHIP.

13:34:21 SO THAT IS KIND OF SOME OF THE PRINCIPLES BEHIND THE MODEL WE ARE PROPOSING. AND I THINK LASTLY SOMETHING THAT WAS DIFFERENT AND WE WILL GO TO THE NEST SLIDE, IT'S PART OF THE NEXT SLIDE. OKAY. WOULD BE THAT MOST MODELS THAT WE LOOKED AT REALLY ONLY FOCUSED ON PARTICIPATION COMING FROM THE CLIENT OR CONSUMER. 13:34:55 IN THIS CASE, WE REALLY WANTED TO FOCUS ON PARTICIPATION AND REALLY ACCOUNTABILITY COMING FROM BOTH PROVIDER OR GOVERNMENT, AND THE INDIVIDUAL.
