PLEASE READ IN ADVANCE OF MEETING: California Judicial Council - COVID- In Person Protocols:

Upon arrival on the 3rd floor, all members of the public attending the meeting will be required to either (1) provide proof of full vaccination against COVID-19, or (2) provide a negative COVID-19 test (obtained no earlier than 72 hours prior to arrival).
