PLEASE READ IN ADVANCE OF MEETING: California Judicial Council - COVID- In Person Protocols:

Upon arrival on the 3rd floor, all members of the public attending the meeting will be required to either (1) provide proof of full vaccination against COVID-19, or (2) provide a negative COVID-19 test (obtained no earlier than 72 hours prior to arrival). Anyone who fails to provide either proof of vaccination or a negative COVID-19 test upon arrival will not be admitted to the meeting. All meeting attendees are required to perform a self-screening assessment for symptoms listed on the CDC’s website prior to traveling to the program location and daily if attending a multi-day program. Anyone who (1) is experiencing any of the COVID-19 symptoms listed on the CDC’s website, (2) is diagnosed with or has tested positive for COVID-19 within the last 10 days, or (3) within the last 14 days has been in close contact with someone infected with COVID-19, should not attend the program.
