

Goal Two: Research



Goal Two: Research (\$37.3 Million)

- 2022 (\$8.7M) awarded to study women, communities of color, and underrepresented populations including LGBTQ+
- 2020 (\$7.6M) awarded to study caregiving, prevention, early detection, long-term services and supports (LTSS) and health disparities
- 2019 (\$21M) awarded
- \$657,000 raised in 2021 through the state's voluntary tax check off for Alzheimer's research



Goal Three: Awareness (\$8.5 Million+)

- Calfiornia Department of Public Health (CDPH) awarded \$8.5M and currently soliciting proposals to launch statewide, multilingual public awareness campaign focused on risk reduction
- Half of Healthy Brain Initiative counties commit to local public awareness campaigns emphasizing language access and cultural competence
- CDA COVID-19 Campaigns include links to Alzheimer's Association 24/7 Helpline – reaching more than 2 million households

Goal Four: Portal (\$5 Million)

- CDA in phase two of statewide web portal development - a key pillar of California's "No Wrong Door" system that bridges Area Agencies on Aging, Aging and Disability Resource Connections and Community-Based Organizations
- Next phase includes 24/7 contact center, standard intake and referral process, and shared marketing/branding





Draft MPA Recommendations

- Recommendations for next phase of MPA
- 2023-24 activities
- Present on 9/20 at MPA: CA for ALL Ages & Abilities
- #1 Training & career pathways for direct care & healthcare staff
- #2 Culturally and linguistically competent communications
- #3 Caregiver support

#1 – Training and Career Pathways

- Expand training for direct care staff and providers in healthcare settings serving older adults, including those with Alzheimer's.
- Explore ways to expand career pathways for direct care staff, including the feasibility of tying training to wage increases and expanding community college certification programs for direct care staff.

#1 – Training and Career Pathways (cont.)

Suggested Steps

- Expand Dementia Care Aware training for all care providers in healthcare settings
- Training and certification program for direct care staff
- Tie enhanced training to wage differentials
- Provider engagement paid time off for staff training & increased wages for trained staff
- Pilot certificate programs with community college(s)

#1 – Training and Career Pathways (cont.)

Advancing Equity

- Improve quality of care for diverse Californians living with dementia
- Provide career path for diverse, largely low-income caregiver workforce
- Improve caregiver ability to provide culturally and linguistically responsive care

#2 – Culturally & Linguistically Competent Communication

- Continue to expand culturally and linguistically competent communications to older adults, people with disabilities, and families.
- This can reduce barriers that cause social isolation, especially for those who are non-English speaking or limited English speaking who are new immigrants to the United States.

#2 – Culturally & Linguistically Competent Communication (cont.)

Suggested Steps

- Prioritize using bilingual and bicultural translators to create communications
- Work with local community-based organizations
- Create inventory of culturally and linguistically competent
 materials
- Create registry of translators

#2 – Culturally & Linguistically Competent Communication (cont.)

Advancing Equity

- Ensure that older adults, people with disabilities and those who are non- or limited-English speaking have access to resources
- Reduce social isolation

#3 – Caregiver Support

Support the needs of unpaid/family caregivers through a multi-prong approach of

- providing financial support,
- offering training, and
- Increasing investments in, and access to, respite services

#3 – Caregiver Support (cont.)

Suggested Steps

- Financial support for unpaid caregivers
- Increase access to and awareness of state-developed training
- Expand Alzheimer's Day Care Resource Centers
- Increase investment in respite services, especially for communities of color

#3 – Caregiver Support (cont.)

Advancing Equity

- Out-of-pocket expenses for unpaid caregivers in the Black, Latino and AAPI communities are higher than statewide average
- Alzheimer's disproportionately impacts Black and Latino families
- Important to increase access to training, respite and financial support focused on underserved communities

State Legislative Update

- 5 Alzheimer's Specific Bills Introduced
- Diverse Bills Introduced In Both Houses
 Including:
 - Long-Term Services & Supports/Affordability
 - Conservatorship
 - Law Enforcement Training
 - Housing
 - Home & Community Based Services

ALZHEIMER'S SPECIFIC BILLS

AB 2175 (Rubio) - California Wandering Task Force - Held in Appropriations

•

- Sponsored by ALZ LA/Orange County/San Diego
- Convened Under the
 Department of Justice
- Focused on Statewide Recommendations to Address Wandering
- 20 Members
- To Meet 4 to 6 Times

Representatives Include

- Department of Aging
 - Law Enforcement
- Counties
- Service Providers
 - Hospital Systems
- Regional Centers

AB 1684 (Voepel) - Alzheimer's Public Awareness Campaign - Held in Appropriations

- Author Drafted
- Requires Department of Aging to Implement a Public Awareness Campaign
- Amended to include a focus on unpaid caregivers

AB 2583 (Mullin) - Held in Appropriations

Dementia Training for Law Enforcement

- Dementia competency included in crisis intervention training for Police Training Officers
- Alzheimer's and dementia specific training required for all officers by 2030

- Funding request coming soon
- Similar efforts cost \$2-10M for development training & backfill for officers during training



SB 861 (Limón) - On Governor's Desk

Dementia Care Navigation

- Provide dementia care
 navigation
- Tools for community health workers (CHWs), promotores and health navigators



- Governor's proposal: \$281M for Community Health Workers in dementia & other areas
 - Administered by HCAI
- Dept. of Aging would administer
