He was also the political director of the Prop 63 campaign of 2004, another successful measure which has raised billions of dollars for mental health treatment and prevention. Subsequently, Robert became a legislative advocate for American Federation of State, County and Municipal Employees (AFSCME) and then SEIU advocating for homecare (domestic) workers to fight for the rights of workers – primarily people of color – who were excluded from the Fair Labor Standards Act of 1938. Robert is now joining this working group to provide help to ensure that the same cycle does not reoccur with youth behavioral health.
