HUMBOLDT COUNTY CPRG ORIGINS


- Attorney General (AG) Stipulated Judgment Requirement
 - 2018 2022
- Recommendation by Evident Change (EC) for inclusion in Judgment
 - EC conducted data analysis on Humboldt County reporting trends
- Online Mandated Reporter Guide one of over 30 requirements in AG Stipulated Judgment
- Humboldt County is currently in early implementation stage of CPRG

2018 Workgroup Developed Initial Draft

CHALLENGES

- Framed as a CWS corrective action item with court ordered deadlines
- CWS as the lead agency
- No formal partner agency
- Mandated reporter buy-in
- Community Task Force as workgroup open venue participation with new/changing participants
- Concerns from Tribal community
 - Example No cross report to Tribes regarding their members when report not made to CWS hotline. Humboldt County policy is to notify Tribe at Hotline for all reports received involving one of their members.

RECOMMENDATIONS

- Mechanism to connect families to prevention/entitlement/beneficial programs as the driver
- CPRG that structurally supports warm handoff and connection to prevention services
- Lead agency not CWS
- Readiness/buy-in from mandated reporter community
- Tribal consultation
- Agency identified early on for implementation/sustainability
