Task Force Name	
Purpose	The Behavioral Health Committee was formed out of a clear consensus of the Child Welfare Council that despite statewide efforts to improve access to behavioral health services for child welfare-involved youth and those at imminent risk of involvement, there are still significant challenges preventing youth and families from receiving comprehensive and integrated services and supports. Committee members include state agency leadership, representatives from the Governor's Office and State Legislature, children's behavioral health providers, county representatives, caregivers, and advocates. The Committee is tasked with developing best practice recommendations to guide policy and inform statewide efforts to address the behavioral health needs of children and youth more effectively in the child welfare system.
July 2021 through June 2022 Activities and Accomplishments	The Behavioral Health Committee's Universal Array of Services document was approved by the Child Welfare Council in December 2021. This document drove much of the Committee's work in the subsequent months. This document in addition to the Policy Recommendations focused on improving access to care, creating a robust statewide array of services, and developing and tracking meaningful outcomes for youth involved in Child Welfare.

Behavioral Health Committee
The Behavioral Health Committee had robust meeting participation across its quarterly convenings from July 2021-June 2022, despite the continued COVID pandemic and reliance on Zoom. Each meeting included presentations from relevant stakeholders including: Melissa Stafford-Jones regarding the Children and Youth Behavioral Health Initiative (CYBHI), Lishaun Francis from Children Now, and Alex Briscoe from the California Children's Trust, among others. The Committee operates via consensus- based decision making, drafting, and publishing of comprehensive policy recommendations.
The Committee continued its work on developing recommendations from the Universal Array of Services document. Specifically, the Committee has focused on reviewing available outcome data for children and youth, as well as proposed outcomes tied to the CYBHI. In order to support this work, the Committee has hosted a special convening to seek out input from stakeholders to address the development of outcomes related to the CYBHI. The California Health and Human Services Agency compiled the results and is using the to inform the CYBHI. This discussion will continue into FY2022-23 to develop a comprehensive set of POS outcome recommendations under Medi-Cal for youth involved in or at risk of foster care involvement.
The Committee has also engaged in discussions about high-fidelity wraparound services for all foster youth, one of the key services identified in the Universal Array document. The discussion will continue into FY2022- 23 to possibly develop comprehensive recommendations regarding the integration of wraparound in Medi-Cal for all foster youth.
Meeting participation during the COVID pandemic (and continued reliance on Zoom) has ebbed and flowed. The greatest challenge related to this is engaging attendees consistently in the consensus-based work of the Committee.
