Univeral PreKindergarten (UPK) Mixed Delivery Quality and Access Workgroup: Scope, Sequence, and Processes

The Workgroup is charged with recommendations for:

- increasing access to high-quality UPK programs for three- and four-year-old children offered through a mixed-delivery model that provides equitable learning experiences across a variety of settings;
- updating Prekindergarten (PreK) standards to support equitable access to highquality PreK & TK programs through the mixed-delivery model & across all appropriate settings & funding sources; and
- ensuring that recommendations are in alignment with the work of the Master Plan, without recommending new system changes that create increased state or local costs to offer PreK across the mixed-delivery system.

Inclusive Early Education Expansion Program

Inclusive Early Education Expansion Program (IEEEP) provides \$116 million to grantees to support increasing access to inclusive early learning and care programs for children with disabilities, including children with severe disabilities

Focus on collaboration and partnerships for professional development opportunities to include:

- Quality Counts California
- Subsidized Community Based Organization staff
- Subsidized Tribal Childcare staff

Inclusive Early Education Expansion Program

Inclusive Early Education Expansion Program (IEEEP) provides \$45 million to support state level systems building and professional development.

- Funds will be used to support a high level of need for a variety of igodolprograms, not just the California State Preschool Program (CSPP), in several areas including:
